

BLACK CROWN FRIDGE COOLER COMPETITION RULES

1. INTRODUCTION

This promotional competition ("Competition") is run by The South African Breweries (Pty) Ltd ("Promoter") and is open to all persons of 18 years or older and resident in South Africa, except for: (a) the directors, members, partners, agents, consultants or employees of the Promoter and their immediate families; (b) the directors, members, partners, agents, consultants or employees of any suppliers of any goods or services to the Promoter in respect of this Competition; (c) directors, members, partners, agents, consultants or employees of the Promoter's advertising and promotion agencies or associated companies; and (d) participating outlet owners and staff.

- The rules set out in this document constitute the rules which will govern the Competition ("Competition Rules").
- Participation in the Competition by an entrant (a "Participant") constitutes acceptance of these Competition Rules by that Participant.

2. COMPETITION PERIOD

This Competition will run from **08 April 2024** until **02 June 2024**, both dates inclusive, or until the Promoter provides a public notice that the Competition has ended, whichever is earlier ("Competition Period"). Entries will only be accepted during the Competition Period.

In order to enter the Competition, a Participant must:

purchase 2 X BLACK CROWN GIN & TONIC OR DRY LEMON & MARULA 275ML NRB OR 440ML CAN (the "Qualifying Product") AND SWIPE THEIR PICK N PAY SMART SHOPPER CARD at SELECTED PICK N PAY OUTLETS NATIONWIDE and online on the PnP ASAP platform (the "Participating Outlet") set out in Annexure A;



Participants are liable for their own data and voice charges in respect of the Competition participation as well as any verification process, if applicable.

Entry is only valid through this medium and manner.

5. WINNER SELECTION AND NOTIFICATION

A winner will be selected by a random draw process based on a winner swiping their Pick n Pay Smart Shopper Card. The draw will take place on or before **01 July 2024** and will consist of all valid entries received during the Competition Period.

A winner will be notified by the Promoter via the contact details available on the Smart Shopper details on or before 31 July 2024. If the Promoter is unable to contact a winner, he/she will be disqualified and a substitute winner may at the discretion of the Promoter be selected, using the same winner selection process.

6. WINNER VERIFICATION

A Participant may be asked to provide a copy of his/her legal and valid identity document/passport/driver's license/proof of residential address/proof of purchase, if applicable, in order to be eligible to receive the Prize. The Promoter reserves the right to conduct the validation and verification process via automated means and/or any other means that the Promoter may deem necessary, and by participating in the Competition, all Participants consent to the appropriate validation and verification measures that the Promoter may implement from time to time.

A Prize will only be awarded by the Promoter and a Participant will only be regarded as a winner after the verification process set out in these Competition Rules has been completed to the satisfaction of the Promoter. Failing successful verification of a Participant, a substitute winner may be selected at the discretion of the Promoter.

The Promoter reserves the right to carry out audits in respect of a Participant to verify his/her eligibility and/or the validity of a Participant's entry. After a Participant has been informed of certain Competition requirements by the Promoter or an individual, including (without limitation) those set out in Competition Rule 1.1 (a)-(d), the Promoter may disqualify a Participant if any fraud or cheating or related activity is suspected, including without limitation, through the manipulation of an entry or otherwise falsifying data. Should the Promoter or its agent determine that an entry or Participant is invalid or ineligible, the



relevant Participant shall not be entitled to receive a Prize and will not be compensated in any way.

A Participant will be ineligible to win, and automatically be excluded from winning, a Prize under this Competition if a Participant previously won a prize to the value of R10 000 or more in the preceding 12 months from the start date of this Competition.

In the event of a dispute, the Promoter's decision is final and binding and no correspondence will be entered into.

The timelines stated by the Promoter or its agent must be adhered to. Failing adherence to any timeline, at any stage, may result in disqualification and forfeiture of a Prize in its entirety with no compensation to any party by the Promoter.

In the event of an alteration, amendment and/or cancellation, the Promoter will not compensate any individual for any reason whatsoever.

Each Participant indemnifies and holds harmless the Promoter, its associated companies, and the directors, officers, employees and agents of the Promoter and its associated companies, against any and all claims for any loss or damages, whether direct, indirect,

consequential or otherwise, arising from any cause whatsoever connected to or arising out of his/her participation in any way in this Competition or his/her receipt, participation, ownership and/or use of a Prize. This indemnity is not intended to exclude any liability for any person which cannot be excluded under the Consumer Protection Act 68 of 2008.

The Promoter shall not be responsible for any lost, damaged, corrupted, delayed, incorrect or incomplete entries for any reason whatsoever. Proof of sending an entry will not be accepted as proof of receipt of such entry. The Promoter shall not be responsible for the failure of any technical element relating to this Competition that may result in an entry not being successfully submitted. The Promoter is not responsible for lost, damaged or delayed entries as a result of any network, computer or cell phone hardware or software failure of any kind. No entry from an agent, third party, organized group or entry automatically generated by computer will be valid or accepted. An entry will only be valid and accepted if it complies with all entry instructions and requirements. Any form of network or systems manipulation, including but not limited to Botnets, Sim Farms, Trojans, SMS malware may not be used when entering the Competition.
